# **Accessing Standard UDS Reports**

A quick reference sheet for Primary Care Associations Last Updated April 2023

The Uniform Data System (UDS) is a system through which organizations funded under the Health Center Program (Activity Code H80) or are considered Health Center Program look-alikes (LALs) submit annual performance reports. Health centers report patient demographics, services provided, staffing, clinical indicators, utilization rates, costs, and revenues. The HRSA Electronic Handbooks (EHBs) includes reports based on data collected through UDS which are accessed through the UDS reports.

Primary Care Associations (PCA) were established to create economies of scale for health centers, maximize the federal Section 330 investments in states, assess and monitor the policy and regulatory environments, and assist health centers in adapting to changing demands from an evolving health care environment. PCAs facilitate collaboration between health centers and Governors, Medicaid Directors, and state health departments to educate them on the Health Center Program and its value to patients, and to work with health centers on the best approaches to meet the needs of their constituents.

This quick reference guide provides instructions for how to access your state UDS reports.

## Accessing UDS Reports and Health Center Data File in the HRSA EHBs

Perform the following steps to access your UDS reports:

- 1. Log in to the EHBs.
- 2. In the Top Navigation panel, click the Grants tab (Figure 1).

# List of Standard UDS Reports and Health Center Data File

The following reports can be accessed using the instructions in this quick reference guide.

## **UDS National and State Rollups**

This report compiles annual data reported by Health Center Program (HCP) Health Centers. Summary HCP data are provided for patient demographics, socioeconomic characteristics, staffing, patient diagnoses and services rendered quality of care, health outcomes and disparities, financial costs, and revenues.

## **UDS Health Center Trend Report**

This report compares the health center's performance for 16 key performance measures (in three categories: Access, Quality of Care/Health Outcomes, and Financial Cost/Viability) with national and state averages over a 3-year period.

## **UDS Summary Report**

Provides the summary and analysis on the Health Center's current UDS data using measures across various Tables of the UDS report. The Preliminary version of this report will only have the Awardees view available.

# **UDS Health Center Performance Comparison Report**

Provides the summary and analysis on the Health Center's latest UDS data giving details at Awardees, State, National, Urban and Rural level with trend comparisons and percentiles.

## **UDS Health Center Data File**

The UDS data file is a comprehensive health center data dump in Excel format to provide health center's raw data specific to the Primary Care Associations (PCA).
