## **COVID-19 Funding Uniform Data System (UDS) Reporting Guidance**

Health centers directly received funding from a variety of sources designed to aid the Federal<sup>1</sup> response to the COVID-19 pandemic. The table below outlines common funding sources administered to health centers and where they should be reported in the UDS Report. Health centers should report the amount drawn down during the calendar year (not the full grant award amount), regardless of how much was spent during the year.

If there is any interest paid by the health center to the lender on any unforgiven portion, the interest expense only would be reported on Table 8A as a cost.
