


## Bureau of Health Workforce Awardees: 2020 At a Glance

#### The Program

In calendar year 2020, 18 Bureau of Health Workforce awardees (BHWs) provided services to 16,877 patients with 60,802 visits. In the previous year (2019) there were a total of 21 awardees reporting.


# Patients: Socioeconomic Characteristics

- 91% with known incomes are at or below 200% of the Federal Poverty Guidelines
- 22% are uninsured
- 57% have public insurance (Medicaid, Medicare, or Other Public)



#### **Patients: Minority Status**

- 65% are of racial and/or ethnic minority
- 27% face a linguistic barrier



# **Services Provided**

- 78% of BHWs provided primary medical care services
- 0% of BHWs provided dental services
- 100% of BHWs provided mental health and/or substance use disorder services

## Staffing

BHW awardees employ the full time equivalent of 137 staff members and volunteers.

- 32 are physicians, CNMs, NPs, and PAs
- An additional 27 are nurses and other medical professionals
- 10 are enabling service personnel
- 0 are dental service personnel
- 42 are behavioral health (mental health and substance use disorder) personnel
- 19 personnel provide non-clinical support

#### **Virtual Visits**

- Virtual visit utilization increased significantly from the prior year due to the COVID-19 pandemic
- 100% BHW awardees utilized virtual visits
- 44% of all visits were virtual
- Mental health services were provided most often through virtual visits (62%)

#### **Quality of Care and Outcome Indicators: Clinical Performance**

BHW awardees provide high quality of care. Several clinical quality measures that exceed Healthy People 2030 goals include early entry into prenatal care, screening for depression and follow-up plan, and HIV linkage to care.
