NCC's Purpose and Award Information

- Purpose:
 - Assess progress to date
 - Help determine Year 2 funding (September 1, 2024-August 31, 2025)
- Award Information:
 - Opened March 1, 2024, and are due in the HRSA Electronic Handbooks (EHBs) by 5 p.m. ET on April 12, 2024.
 - Year 2 funding is contingent on federal factors and satisfactory progress
 - Year 2 ECD funding released on or around the start date of September 1, 2024.

Information presented in the Project Work Plan form should align with the presented budget.

Work Plan Update

- Updates/progress to activities
- Add/describe new activities.
- Successes and lessons learned

Activities Consistent with Budget

- Document activity, budget, and/or equipment changes
- Yes/No to submitting a prior approval request, if applicable

Barriers

- Issues encountered
- Mitigating steps
