Numerator Description	Children who have evidence showing they received recommended vaccines, had documented history of the illness, had a seropositive test result, or had an allergic reaction to the vaccine by their second birthday.
Denominator Description	<p>Children who turn 2 years of age during the measurement period and who have an eligible countable visit during the measurement period.</p> <p><b>Exclusions:</b></p> <ul style="list-style-type: none"> <li>• Children with any of the following on or before their second birthday: <ul style="list-style-type: none"> <li>○ Severe combined immunodeficiency</li> <li>○ Immunodeficiency</li> <li>○ HIV</li> <li>○ Lymphoreticular cancer, multiple myeloma, or leukemia</li> <li>○ Intussusception</li> </ul> </li> <li>• Children who were in hospice care during the measurement period</li> </ul>
