

### **Overview of the FTCA Free Clinic Program**

The Health Insurance Portability and Accountability Act (HIPAA) granted medical malpractice coverage through FTCA to volunteer Free Clinic health care professionals. The Patient Protection and Affordable Care Act extended this coverage to Free Clinic board members, officers, employees, and individual contractors.

A Free Clinic must apply for and sponsor a qualified individual for FTCA medical malpractice coverage deeming. FTCA medical malpractice protection provides the covered individual with immunity from medical malpractice lawsuits resulting from his/her subsequent performance of clinical medical, dental, or related functions within the scope of his/her work at the Free Clinic.

The Free Clinics FTCA Program has four major program requirements that are based on statutory requirements\*\*:

- Credentialing and Privileging System
- Quality Improvement/Quality Assurance (QI/QA) program, including a risk management (RM) system
- Professional Liability
- Annual Data Reporting

## **Requirements of Sponsoring Clinics**

The sponsoring Free Clinic must meet the following requirements:

- Must be a 501(c)(3) organization
- Must be licensed or certified in accordance with applicable state law
- Must not receive any compensation for service from individual or third-party payor (Note: Free Clinic is allowed to accept donations)

## **Credentialing and Privileging**

#### Credentialing

Process of assessing and confirming qualifications Credentialing Elements

- Verify Licensure
- Verify Education, and Training
- Ability to Perform Job
- Identification

#### Privileging

Process of authorizing the specific scope and content of patient care services provided

# Requirements of Free Clinic Health Professionals

- Free Clinic health professionals cannot receive any compensation for service from individual or third-party payor
- Health Services must be provided at the Free Clinic or through sponsored offsite programs or events
- Individuals who are volunteer health care professionals must be currently licensed or certified to provide health care services

#### **Privileging Elements**

- Verify and Assess Competence based on the course of training as required to perform defined procedures
- Free Clinic must have implemented policies and procedures to assess that the Free Clinic volunteer has the required competence and skills needed to perform their scope of work within the Free Clinic

# Quality Improvement/Quality Assurance Program (QI/QA)

The Free Clinic must have a QI/ QA plan:

- Identifies the Free Clinic's plan to mitigate risk and improve quality care for patients
- Outlines the process for identification and evaluation of concerns, education plan for staff members, and responsibilities of management
- Includes the Free Clinic's credentialing and privileging process

## **Patient Notice of Limited Liability**

- Free Clinic must provide each patient with written notification of the limited liability of the health care professional pursuant to FTCA
- The notification must be written and provided by the sponsoring Free Clinic or deemed individual
- Highly recommended that Free Clinics provide the notification prior to the first visit and obtain the patient's signature

On an annual basis, all Free Clinics with FTCA deemed individuals must submit data on the number of patient visits, deemed providers and
