Subrecipient agreements must require compliance with section 330 program requirements in order for the services and/or the site to be considered within the scope of the 330 project.

Refer to <u>Uniform Guidance 2 CFR part 200 as codified by HHS at 45 CFR part 75</u> for more information on the characteristics of a subaward.<sup>1</sup> Under 45 CFR 75.2, "a subaward may be provided through any form of legal agreement, including an agreement that the pass-through entity considers a contract."

However, it does apply to contracting for the entire key management team or the majority of health care providers with a single entity.
